Internationalisation among VET schools and Guidance Centres (focused primarily on internationalisation within Erasmus+ programme). Cross-sectoral cooperation within compulsory school and VET sector.</p> |

The participants will through get access to a broader European network, which will be a platform for sharing of experience.
