TCA DESCRIPTION

Themes and goals:	<p>The question of responsible internationalization is increasingly relevant in international higher education partnerships. Shifts in geopolitics and security concerns now touch academic cooperation as well. With this TCA, we invite participants to explore these themes. By responsible internationalization, we refer to ensuring knowledge security and managing geopolitical risks in international academic cooperation, while simultaneously safeguarding core academic values. The program includes expert presentations on best practices and interactive workshops designed to deepen understanding and foster collaboration around these topics. Our goal is to provide a practice-oriented programme that stimulates reflection and equips participants with practical ideas and tools for their daily work in higher education institutions. The event focuses on three key themes: Mobility practices and responsible implementation Due diligence in international partnerships Security and ethical considerations in international cooperation</p>
