Themes and goals:

The event will concentrate on discussing how HE stakeholders can contribute to EHEA and Erasmus+ objectives, by enhancing digital and green transformations, promoting interconnectedness, and bolstering international cooperation, inclusion, and diversity. All PROFFORMANCE products are aligned with these priorities, emphasizing a student-centred approach which aim to support HEIs and educators in this journey. Through structured discussions and networking opportunities, participants will establish valuable connections, fostering longterm collaboration and impactful partnerships.
