The participants are able to make contacts that will facilitate placement for job-shadowing/teaching assignment for staff and/or will facilitate pupils'/learners' mobility.

Participants do not coordinate a consortium nor are they a consortium member. Each sending NA must make sure that the participant is indeed of this type. Participants need to have good command of English to be able to participate actively. Participants are expected to take part in the whole TCA and can not leave early. They should make travel arrangements accordingly.
