### TCA DESCRIPTION

<b>Themes and goals:</b>	NO01 invites to a national seminar for Erasmus+ projects focusing on green transition and sustainability. The seminar "Greening my project: A training for beneficiaries on the Green priority in Erasmus+" offers project coordinators the opportunity to strengthen their competence in climate and environmental issues, and to gain concrete tools to make their projects more sustainable—regardless of the project's theme. Through a varied program, participants will gain insight into sustainability as a priority in Erasmus+, and how to integrate environmentally conscious choices into all phases of a project. The seminar combines expert presentations, interactive workshops, and project visits, and facilitates experience sharing and networking among project leaders from across the country.
