Allyship: Recall participants about the concept of allyship and how individuals can actively support marginalized groups.Goals:1.Recall European Commission dimensions of Inclusion and Diversity within collaborative projects.2.Practice collaboration between participants fostering an inclusive network of individuals committed to diversity and inclusion.3.Analyze the importance of inclusion and diversity in various aspects of life, such as workplaces, educational institutions, and communities. 4.Demonstrate the benefits of diversity, including improved creativity, innovation, and overall organizational performance.5.Design practical strategies and tools for creating inclusive and equity European projects. 6.Debate best practices for fostering an inclusive culture, such as inclusive language, policies, and practices that value and embrace diversity.</p>
