<b>Themes and goals:</b>	<p>The aim of this cross-sector, transnational Inclusion Conference (working title 'Embracing Inclusion') is to gather and disseminate the realities, achievements and aspirations of national and international inclusion projects under the Erasmus+ and European Solidarity Corps programmes. This 3-day conference will emphasize the cooperation between different sectors (Youth, VET, AE, formal education, social business sector, etc.), as well as between different programme countries. Embracing Inclusion will concentrate on four specific inclusion topics relevant to young people and young adults: Support for those in NEET situation / facing economic obstacles Building resilience against extremism or radicalisation Strategies for those from disadvantaged rural areas / facing geographical obstacles Approaches to assist people with health issues, disability and mental (ill) health</p>
